The Agenda Item was taken and discussed as follows.

1. Regarding Anomalies in Budget a number of measure taken in budget was discussed thoroughly by all members by different angle but meeting was informed that many of them already taken by APMSPIDA representative at KCCI and FPCCI so no new item was found to discuss.
2. Regarding increased in petroleum prices all members were unanimously agreed that some special measures should be taken to support the poor class of motorcyclist who goes to their shops and jobs every day on motorcycles due to absence of proper transport system in the Cities and especially in Karachi.
3. Various suggestion to accommodate the poor Motorcycles user were discussed but nothing concrete results were found feasible for the government to use them at large scale in the whole country.
4. Government announcement to pay two thousand rupees per month to poor families whose income is less than 40,000 could not find much workable in this case.
5. However after discussed the Economic situation of the country it was decided to face the hard situation by everyone in their own capacity for the time being until the hard time is over.
