Dear Members,

As a result of the scrutiny being conducted by the members of the Election Commission of APMSPIDA of the nominations received by the members for filling in the six (6) seats of Executive Committee of APMSPIDA for the year 2021-22 and subsequent withdrawal of nominations to avoid appearance of candidates name on the ballot paper, we wish to apprise the following:-

- 1. That, initially for filling in the two (2) seat allocated for the North Zone, APMSPIDA had received two (2) nomination and for filling in the remainder four (4) seats allocated to the South Zone, APMSPIDA Election Commission had received six (6) nominations within the stipulated date.
- 2. That, during the stipulated time, no objections were received by the Election Commission on the aforementioned 8 nominations.
- 3. Subsequently, two (2) nominees belonging to South Zone withdraw their nominations, thereby leaving behind four (4) seats to fill in the vacant four (4) positions of South Zone.
