## **Minutes**

The emergent meeting of the Executive Committee under the chairmanship of Mr. Muhammad Tariq Siddiqui, Sr. Vice Chairman started off with the recitation of the verses from the chair himself.

The members unanimously decided that in order to manage the proffers received from the members of APMSPIDA for the placement of advertisements in the Annual Diary of the Association, the members of the Executive Committee were pleased to pass the following terms and conditions for the needful compliance by the respective proffer senders:

- If two or more proffers are received from the members (thereby expressing their desire for the placement of their establishment's advertisement at the front cover or the hind side) then such members will have to undergo the balloting process in order to determine the successful establishment in this respect.

*Proviso: The establishment successful in making to the front cover of the Annual Diary will not be entitled for the balloting for the hind cover and vice versa.*

- All the proffer senders may deposit non-refundable Rs. 30,000 cash/cheque/pay order favouring APMSPIDA in order to get entitlement for the balloting.

*Proviso: The establishments remaining unsuccessful in the balloting will eventually be accommodated on other available slots in the Diary (other than on the front and hind page).*

- The Advertisement slots are non-transferrable. The successful establishment(s) cannot in anyway transfer their respective slot(s) to any other establishment. Anyone found violating the same will end up losing its respective slot alongwith no refund of contributed amount.

The meeting concluded with the vote of thanks to the Chair.
