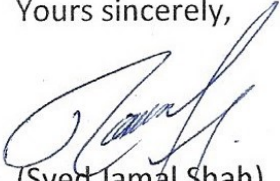
1 – Nomination forms can be obtained from APMSPIDA head office or can be downloaded from APMSPIDA official website www.pkmspida.com.
