Dear Members,

As a result of the scrutiny being conducted by the members of the Election Commission of APMSPIDA of the nominations received by the members for filling in the twelve (12) seats of Executive Committee of APMSPIDA for the year 2026-28 and subsequent withdrawal process of nominations (if any) to avoid appearance of candidates name on the ballot paper, we wish to apprise the following:-

1. That, for filling in the three (3) seats allocated for the North Zone, APMSPIDA had received three (3) nominations and for filling in the remainder nine (9) seats allocated to the South Zone, APMSPIDA Election Commission had received eleven (11) nominations within the stipulated date.
2. That, during the stipulated time, no objections were received by the Election Commission on the aforementioned 14 nominations.
